What data do we collect?

How do we collect your data?

- Use or view our website via your browser's cookies.

How will we use your data?

How do we store your data?

Our Company securely stores your data via e-mail.

Our Company will keep your contact information for a period of one year. Once this time period has expired, we will delete your data by deleting the e-mail with the data.

You have the right at any time to stop Epitome Tech Lab from contacting you.

If you no longer wish to be contacted, please reply to our e-mail with a relevant word, such as "unsubscribe", "stop", "disenroll", etc. A human will read all of your e-mails and will treat you with consideration of your privacy needs and requirements.

What are your data protection rights?

Epitome Tech Lab would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Epitome Tech Lab for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Epitome Tech Lab correct any information you believe is inaccurate. You also have the right to request Epitome Tech Lab to complete information you believe is incomplete.

The right to erasure – You have the right to request that Epitome Tech Lab erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Epitome Tech Lab restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Epitome Tech Lab's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Epitome Tech Lab transfer the data that we have collected to another organization, or directly to you, under certain conditions.
